#### New grant program affirms importance of shoring up coastal wetlands (FWS)

More than \$17 million will be awarded by the U.S. Fish and Wildlife Service to 20 projects in 10 coastal states to protect, restore, or enhance more than 13,000 acres of coastal wetlands and adjacent upland habitats under the National Coastal Wetlands Conservation Grant Program.
