



Protect Key Ocean Habitats (Canyons, corals, key fish habitats, migration corridors for birds, marine mammals and sea turtles)


Update: MARCO reviewing criteria to be used to identify and evaluate significant offshore habitats

Update: MARCO is evaluating opportunities to address atmospheric contributions of nitrogen to marine waters via federal consistency


